Deposit & Payment Policy:

If not taking advantage of early booking promotion, a deposit for the first 3 categories of \$900 per person is due with booking. \$600 may be by credit card. \$300, which covers port taxes and group booking fees must be by check. The Suite deposit amount is \$1125 per person. \$825 can be paid by credit card. \$300 must be paid by check.

Air deposit will be required at a later date.

Travel insurance is highly recommended and must be paid by credit card with deposit.

Final payment is due March 1, 2019.

Cancellations & Refunds:

- For cancellation 120 or more days prior to travel, a cancellation fee of \$300 per person will apply.
- For cancellation 119 – 90 days prior to travel, a cancellation fee of 20% of cruise fare will apply.
- For cancellation 89 – 60 days prior to travel, a cancellation of 35% of cruise fare will apply.
- For cancellation 59 – 30 days prior to travel, a cancellation of 50% of cruise fare will apply.
- For cancellation less than 30 days prior to travel, the cruise fare is nonrefundable.
- All monies paid for air are nonrefundable.
